GROWER WAREHOUSE RETURN ORDER FORM

This form is to be used if Growers sell their Grain to a Buyer on an “Ex Store” basis or retrieve from warehousing for their own use.

INSTRUCTIONS

1. Grower must complete sections A, B and C. A separate form is required to be completed for each site/grade/season combination.
2. This form is to be faxed to GrainCorp Stocks Department a **minimum of 3 working days prior to intended movement**. You will be advised by return fax; availability of Grain, site contact, a Warehouse Grain Stock Order Number and expiry date, together with a Grain Outturn Truck Booking form (refer step 4).
3. Private contractor or nominated carrier must **phone the contact person (as advised) a minimum of 24 hours prior to intended movement** to arrange an appointment. The Warehouse Grain Stock Order Number must be quoted in order to confirm availability and arrange a suitable time to outload grain.
4. Upon confirmation of outloading with site contact, complete and return the Grain Outturn Truck Booking form (as provided) to notify truck registration numbers. This form must be received at the Logistics Department **by no later than 3.00pm the day prior to outloading**.
5. The Warehouse Grain Stock Order number, as advised by the Graincorp Stocks Department, must be quoted at the weighbridge prior to outloading **each** load of grain.
6. Grain Stock Order's are only valid for the calendar month they are placed. Grain not outloaded prior to expiry date remains in Grower's ownership and may incur additional storage charges. Please contact the GrainCorp Stocks Department if your order has expired or will expire prior to the completion of outloading.
7. Applicable Storage and Logistics fees will be Invoiced after outloading has occurred and the Grain Stock Order has expired.
